# **SHORT BIO**

I am a professional with fourteen years of relevant work, academic, and teaching experience in the following fields: genocide studies, crimes against humanity, human trafficking & forced labor, the international criminal justice system, international terrorism, violent crimes committed against children, freedom of religion or belief (FoRB) rights, and religious persecution. I hold a Ph.D. in International Criminal Law and a Master's in International Humanitarian Law.

I have worked as a lecturer and guest professor in several law schools since 2011. I teach courses in Public International Law, International Criminal Law, International Human Rights Law, and International Refugee Law. I am also a member of the Global Association of Human Trafficking Scholars (GAHTS). GAHTS is committed to understanding the historical, political, structural, and cultural components of human trafficking and to producing research-guided advocacy papers to influence the global community.

I authored the book "Beyond a Reasonable Doubt." This book investigates the legal nature and criminal responsibility of the terrorist group Islamic State/DAESH's crimes against civilians in Iraq, especially Christians. I examined whether these crimes constituted genocide or persecution as crimes against humanity under the Rome Statute. The book draws on hundreds of cases from international criminal tribunals and offers a significant and original contribution to the study of genocide and crimes against humanity.

I have served as an intern in several capacities, such as the Permanent Mission of Brazil to the United Nations in Geneva and the War Crimes Research Office in Washington-DC. I have already volunteered in different projects assisting poor and marginalized communities. From July to September 2023, I served Syrian refugees as an English language and photography teacher at a

community center in Mafraq, Jordan. In September 2019, I served the Refugees 4 Refugees NGO in Greece, providing practical and logistical support to refugees and asylum seekers in a refugee camp on Samos Island. From February 2018 to December 2021, I served an NGO in Istanbul that assists refugees, asylum seekers, undocumented migrants, and unaccompanied children. There, I taught International Refugee Law to the NGO's volunteers and trained them on the practical aspects of refugee protection in Turkey. I also directly provided logistical support to undocumented children.

I am also a humanitarian photographer. I want people to see the suffering in the world through the eyes of my lens. I also want access to areas of international conflict so that my photographs can be used as criminal evidence. I want to use my storytelling skills to inform, provoke discussion, and inspire action.
